Living by Cooperative Principles for over 85 Years

First energized in 1936, Barron Electric Cooperative has been providing reliable electricity to our members. As a cooperative, we live by the seven cooperative principles including:

1. Voluntary and Open Membership:

Membership in a cooperative is open to all persons regardless of race, religion, gender or economic circumstances.

2. Democratic Member Control: Cooperatives are democratic organizations controlled by their members. Barron Electric's Board of Directors consists of nine members who are elected to represent the best interests of the membership.

3. Members Economic Participation: Members contribute equitably to, and democratically control, the capital of their cooperative. Barron Electric returns margins to members based on their usage, also called cashback credits or capital credits.

4. Autonomy and Independence: Cooperative are autonomous, self-help organizations controlled by their members.

5. Education, Training, and Information for members, directors and employees.

6. Cooperation among cooperatives: one example is ROPE, which is Restoration of Power in an Emergency, where cooperatives work together to restore power during large-scale outages.

7. Concern for community: Barron Electric has been a strong supporter of the communities they serve, from providing funding to non-profit groups, sponsoring events, and allowing employees to use community service hours to help various groups.

Larry Kuhl represents District 5 on Barron Electric's Board of Directors, which includes the townships of Long Lake, Bear Lake, Oak Grove, Stanfold, Rice Lake, and Doyle.



- Director Kessler gave the treasurer's report, with comments by General Manager Torud. A report of vouchers for the month was presented as part of the board packet as follows: #99431 thru #99571 of CCF Bank was in the amount of \$290,329 and capital credit estate checks in the amount of \$15,271. Director Kessler reported on activity of total receipts in the office - \$2,533,696; total receipts by wire and ACH - \$1,420,539; disbursements by ACH, EFT, wire - \$3,453,830; transfer of funds was made for payroll - \$195,808 and power bill paid 10/27/2021 in the amount of \$1,661,265.
- A membership list of 93 was presented and approved without objection by the board.
- Form 219 summarizing construction activity for the month of September in the amount of \$376,249.54 was presented for approval, and included new services - \$42,313.11; change jobs - \$23,672.46; miscellaneous - \$310,263.97 and 3 retirements. The Form 219 stood approved as presented.
- Outages year-to-date stand at 19,647 consumer hours off, which is 22.63% below 2020 hours of 25,395. Overtime year-to-date is 2,842.25 hours, which is 6.19% below 2020 hours of 3,029.75.

5. Nominations of candidates to the post of Director may be made from the floor during the Annual Meeting on Saturday, March 26. All formal resolutions which are to be presented to the annual meeting will be reviewed by a Resolutions Committee prior to the Notice of the Annual Meeting being sent. This will not restrict the right of any member-consumer to make simple motions at the Annual Meeting. Copies of resolutions to be presented and considered at the Annual Meeting will be mailed in advance to the membership so that each member-consumer will have time to consider the same.

All resolutions must be in writing, properly signed, dated, and with member-consumer's address and phone number. Hand-written resolutions will be considered only if legible as determined by the Resolutions Committee.
