

### Improving Reliability at the Shell Lake Substation

Barron Electric Cooperative line crews worked with Dairyland Power Cooperative and Dawes Rigging & Crane Rental to install a new 10 MVA transformer at the Shell Lake Substation to help improve reliability. The new transformer weighed in at 55,000 pounds. Transformers are used for receiving energy from higher voltage levels and then transform and distribute this energy to lower voltages. Members on the Shell Lake Substation did not experience an outage, since they were backfed to two substations. Line Superintendent Scott DeVoe remarked, "I used the SCADA System to operate electronic oil circuit reclosures at 4 different substations, which made the process more efficient."

#### Condensed Board Minutes March 28, 2019

- Director Helm gave the treasurer's report, with comments by Manager Sloan. A report of vouchers for the month was presented as part of the board packet as follows: #95796 thru #95965 of CCF Bank was in the amount of \$769,628 and capital credit estate checks of \$11,518. Director Helm reported on activity of total receipts in the office \$2,440,421; total receipts by wire and ACH \$1,173,939; disbursements by ACH, EFT, wire 2,743,612; transfer of funds was made for payroll \$169,976 and power bill paid 03/27/19 in the amount of \$2,359,257.
- Form 219 summarizing construction activity for the past month in the amount of \$86,524.81 was presented for approval, and included new services \$13,456.09 change jobs \$0; miscellaneous \$73,068.72 and 3 retirements. The Form 219 stood approved as presented.


# Monthly Photo Contest Summer Landscapes



## Cook's Corner

Apricot Rhubarb Jam Flo Tripp

8 cups finely chopped rhubarb

4 cups sugar

1 can apricot pie filling

3 oz. package orange gelatin

Combine rhubarb and sugar in bowl. Allow to stand overnight. Bring rhubarb mixture to a boil. Simmer 10 minutes. Add pie filling. Bring to boil. Add gelatin. Stir until dissolved. Seal in hot jars or freeze.
