Board of Directors Approved New Rate Schedule

Barron Electric Cooperative's Board of Directors approved a new rate schedule, effective May 1, 2018. Dairyland Power Cooperative, Barron Electric's wholesale power supplier, implemented a summer rate in 2012. Barron Electric's wholesale power costs are 11% higher in the summer months. Members will now see a summer energy charge of \$0.1057 per kilowatt hour for

June, July, August, and September. The summer rate more accurately reflects the wholesale power costs. The October - May charge will remain at the current rate of \$0.0957 per kilowatt hour. The fixed charge was increased to \$34.50 per month. The fixed charge is designed to cover each member's share of the cost of maintenance for wires, transformers, meters, right-of-way clearing and other expenses on the

distribution system. The average member will see approximately a 4% increase annually on their electric bill.

Saving Rural Electric Cooperative Members' Money

Governor Scott Walker signed Assembly Bill (AB) 583 into law, which will enhance safety in Wisconsin. AB583 strengthens safety initiatives while protecting our members as not-for-profit entities. The law ensures materials and labor provided by electric and telecommunications cooperatives during a Restoration of Power in an Emergency (ROPE) event are exempt from sales and use tax. Dairyland coordinates the ROPE program, in which Wisconsin electric cooperatives provide each other mutual aid during severe weather events to shorten storm recovery times. Dallas Sloan, Barron Electric's General Manager, testified on behalf of Assembly Bill 583, indicating that the cooperative paid nearly \$7,000 in sales and use tax for outside crews who assisted with power restoration after the May 16 tornado.



General Manager Dallas Sloan thanked Governor Walker for signing a reform proposal that eliminates the double taxation on Wisconsin's sales and use tax on services and materials furnished in mutual assistance between electric cooperatives, as well as telecommunications cooperatives.

Dairyland Power Increases Their Solar Production



Dairyland Power Cooperative, Barron Electric's wholesale power supplier, has finalized agreements for three additional utility-scale solar generation projects, bringing the total number under contract to 18. This will increase the total solar generation to 25 MW in the Dairyland cooperative system. Once the three new facilities are online, the 18 sites will together produce enough renewable energy to power nearly 4,000 homes.



Robert Bitney Wins the Megawatt Community Service Award

Congratulations to Robert Bitney for his outstanding community service. He is currently President of the Chetek Lion's Club, which has over 70 members. Robert started the Great Beginnings Pumpkin Program, which provides pumpkins to elementary school students in the Chetek school district. The Lion's Club also provides vision screening

for over 1,000 students, which helps identify possible vision problems. The club also helped with the relief efforts after the May 16 tornado.

Additionally, he helps with merit badge seminars for Dallas Boy Scout Troop 102. Robert is working towards becoming an Assistant Scoutmaster to help lead successful boy scout troops. He also teaches hunter safety courses for the DNR.


