
# Members Share \$600,000 in Capital Credits

Jennifer Beaudette, Director of Member Services, explained, "Community Rays is a 100 KW solar array that produces enough energy to power 10 homes." She added, "Our average residential member uses 1,200 kilowatt hours per month."

Community Rays was energized in 2014 and has produced over 535,000 kWh.

# Right-of-Way Clearing Improves Reliability

Trees and vegetation growing into the cooperative's right-of-way can cause power outages, block access for maintenance and repairs, and become a safety hazard. The Right-of-Way (ROW) Clearing Program helps reduce contact between trees and power lines.

*Barron Electric will clear trees and brush in the following townships:*

This program helps contribute to members having power 99.98% of the time. Contractors clear trees and brush in sixty-one townships on a rotational schedule every five to six years. This may include mechanical chopping, hand-cutting and side-trimming. No chemicals are used. Only primary lines are cleared, which supply power to the transformer that

serves your location. The following year, Barron Electric line crews perform routine line patrol and trim trees or branches as needed along secondary wires between the transformer and your meter.

If you have trees that are growing into power lines, contact Barron Electric at 800-322-1008. Never try to cut or trim them yourself.

## Condensed Board Minutes August 29, 2018

- Director Helm gave the treasurer's report, with comments by Manager Sloan. A report of vouchers for the month was presented as part of the board packet as follows: #94292 thru #94599 of CCF Bank was in the amount of \$372,903 and capital credit estate checks of \$5,861. Director Helm reported on activity of total receipts in the office - \$2,836,814; total receipts by wire and ACH - \$1,432,935; disbursements by ACH, EFT, wire - 3,923,898; transfer of funds was made for payroll - \$192,247 and power bill paid 08/29/18 in the amount of \$2,717,155.
- A membership list of 133 was presented and approved without objection by the board.
- Outages year-to-date stand at 29,612 consumer hours off, which is 85.1% below 2017 hours of 198,248. Overtime year-to-date is 1,889.25 hours, which is 36.0% below 2017 hours of 2,952.75.

## Cook's Corner

### Chocolate Éclairs From Dan's Kitchen

1 cup water  
½ cup butter or margarine  
1 cup flour  
4 eggs  
8 oz. package cream cheese, softened  
6 oz. package instant French vanilla pudding mix  
1 2/3 cups milk  
1 carton Cool Whip  
Chocolate Fudge Topping

Combine in saucepan water and butter over medium heat. Bring to a boil. Boil for 1 minute. Remove from stove. With wire whisk, stir in flour, stirring until mixture forms a ball. Add eggs one at a time, stirring vigorously after each addition. Spread mixture into a greased 9x13 pan. Bake in 400° oven for 26 minutes (375° degrees for a glass pan). Cool.

In mixing bowl, thoroughly combine cream cheese, pudding mix, and milk. Stir until slightly thickened. Let sit 15 minutes. Spread over baked éclair. Spread with cool whip. Drizzle with chocolate fudge topping. Refrigerate overnight. Cut in squares to serve.
