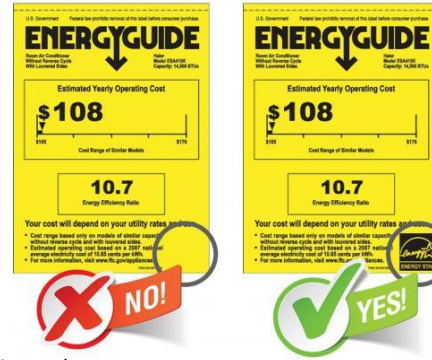


**ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM** *(Please read)*

  - ❖ Please allow 8 to 10 weeks to process the rebate/incentive application.
  - ❖ Appliance recycling qualifies for the entire rebate, regardless of the recycling cost.
  - ❖ Visit [www.energystar.gov](http://www.energystar.gov) to verify ENERGY STAR rating.
    - ❖ The rebate application must be received no later than 3 months after the purchase or by December 16, 2022, whichever comes first.
