ELIGIBILITY CRITERIA & REQUIRED INFORMATION:


Eligibility:

- New & Recycled appliances must be electric
- Submission must be within 3 months of purchase, install or recycle date
- Appliances must be purchased/installed or recycled in 2025 on cooperative lines
- Rebates are valid through December 12, 2025, or until funds are depleted

Required Materials:

- A copy of your receipt or invoice for each appliance; purchased or recycled in 2025
- Receipts for recycled appliance(s) must indicate appliance is in working order Note: Appliance recycling qualifies for entire incentive, regardless of the recycling cost.
- Appliance(s) must be Energy Star rated with guide or energy star documentation for each appliance
