


Barron Electric's Board of Directors Approved New Rate Schedule, effective April 1

Board of Directors approved a new rate schedule effective April 1, 2025. These rates will be reflected on the May 1 electric bill and are listed below. The average residential member using 1,200 kilowatt hours will see a 8.52% annual increase or approximately \$15 per month.

The board has a fiscal responsibility to the membership

and has set financial goals that include increasing equity, returning cashback credits in a timely manner, and continuing to invest in the electric distribution system serving our membership. The increasing cost to provide safe, reliable power is being affected by higher prices for equipment, supplies, interest, technology, software, engineering, and line upgrades. GPS Project Update

Global Mapping Solutions G(GMS), contracted by Barron Electric Cooperative, will continue gathering data on our system, starting in March, which may include working weekends and any daylight hours. They may be on your property by foot, ATV, or UTV, taking photos of Barron Electric equipment, posting signs, or locating cable.

GMS employees will have a badge, letter of contract with Barron Electric letterhead, and their equipment will include a contracted by Barron Electric Cooperative sign.

Once complete, this project will improve the outage dispatch process and provide a safer electric system for line crews, contractors, members, and the public. During outages, this will allow better communication from the cooperative to our membership.

*Condensed Board Minutes December 6, 2024

Tim Kessler is treasurer of Barron Electric's Board of Directors. He represents District 2 which includes the following townships: Evergreen, Spooner, Dewey, Bashaw, and Barronett.

- A report of vouchers for the month was presented as part of the board packet as follows: #103700 through #103825 from CCF Bank in the amount of \$367,498 with capital credit estate checks totaling \$18,333. Total receipts in the office \$1,951,820; total receipts by wire and ACH \$415,545; disbursements by ACH, EFT, wire \$1,638,715; transfer of funds was made for payroll \$222,838 and the power bill was paid on 11/27/2024 in the amount of \$1,826,410.
- The board discussed the dates for holding the 2025 Annual Meeting. Director Warwick moved, Director Mandel seconded, to hold the 2025 Annual Meeting on Tuesday, April 8, 2025 in the evening. Motion carried by a vote of 8 yes, 1 no.
- A membership list of 89 was presented and approved without objection.
- Form 219 summarizing construction activity for the month of October in the amount of \$213,877.67 was presented for approval and included new services \$50,867.66; change jobs \$23,714.52; Other Work Order Projects \$139,295.49 and 14 retirements. The Form 219 stood approved as presented.
- Outages year-to-date stand at 87,096.89 consumer hours off, which is 38.88% above 2023 hours of 62,713.93. Overtime year-to-date is 3,795.25 hours, which is 23.33% above 2023 hours of 3,077.25.
