## **Save Energy This Winter**

Save energy this winter with these simple tips:

- Dirty filters can reduce airflow, which makes your system work harder. Check your filter every month. Change filters when dirty.
- Choose energy efficient appliances. Check Barron Electric's website at barronelectric.com for rebates on energy efficient appliances.
- Use your ceiling fan to keep warm. Make sure your ceiling fan rotates clockwise at a low speed during the winter months. This will create an updraft which forces warm air near the ceiling down into the occupied space. Turn off your fan when no one is in the room.

## **Qualifications for Board Director**

Qualifications for Barron Electric Cooperative Directors, located in the bylaws, are listed below:

No person shall be eligible to become or remain a board member of the Cooperative who:

- (a) is not a member and bona fide resident of the district and on premises served by the Cooperative at his or her primary residence, and that residence is within the director district which he or she has been nominated or elected to represent;
- (b) is in any way employed by or financially interested in a competing enterprise or business selling electric energy, or supplies to the Cooperative or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to the members of the Cooperative;
- (c) has been employed by the Cooperative within the last five (5) years;
- (d) while a director or during the five years preceding the most recent election, or appointment as a director, was convicted of a felony or misdemeanor involving a breach of trust;
- (e) while a director or during the five years preceding election or appointment as a director has pursued any litigation against the Cooperative or any of its employees or directors, or who is in default on any obligation owed to the Cooperative at the time of election or appointment. Upon establishment of the fact that a board member is holding the office in violation of any of the foregoing provisions, the board shall remove such board member from office. Nothing contained in this section shall affect any manner whatsoever the validity of any action taken at any meeting of the board.

- Review your electric use, payment, and billing history.



## Time of Use Rate Available\*

The Time of Use Rate is designed for members who are able to shift more of their electricity use to lower demand or off-peak periods. This rate more accurately passes along the real-time cost of electricity. Electrical energy is more expensive during periods of high demand and less expensive when demand is low. By choosing the Time of Use Rate and shifting electricity use to lower-demand time periods, you have the opportunity to save money on your electric bill. Some items to consider:

- Is anyone home during the on-peak hours?
- Do you heat and air condition your home with electricity?
- Do you or could you use a programmable thermostat?
- Do you have a hot tub? Could you use a timer for these?
- Do you use an electric water heater?
- Do you use an electric dryer?
   If you are able to control when you use electricity and shift more of your usage to off-peak times, you may benefit from this rate.

\*Eligibility requirements may apply. SmartPay, Distributed Generation, and Community Rays accounts do not qualify for this rate. Please contact the Billing Department at 800-322-1008 or billing@barronelectric.com for more information.

## How Can You Run for a Director Position?

- 1. Director nominees should obtain a petition from Barron Electric's office.
  - Requires signatures from ten(10) members, living within the director district that the nominee would represent
  - Nominees must meet director qualifications as printed in the Cooperative Bylaws. See page 2 for qualifications.
- 2. A photograph and candidate information submitted with the signed petition will be published in the candidate profile.
- 3. Petitions must be received by 12:00 p.m. (noon) on **Friday**, **February 14, 2025** in order to have nominee's name appear on the printed ballot.
- 4. Mail petitions to: Barron Electric Cooperative, Attn: Jennifer Horstman, PO Box 40, Barron, WI 54812.
- 5. Nominations of candidates to the post of Director may be made from the floor during the Annual Meeting on Tuesday, April 8.

#### Resolutions

All formal resolutions, which are to be presented to the annual meeting, will be reviewed by a Resolutions Committee prior to the Notice of the Annual Meeting being sent. This will not restrict the right of any member to make simple motions at the Annual Meeting. Copies of resolutions to be presented and considered at the Annual Meeting will be mailed in advance to the membership so that each member will have time to consider the same.

All resolutions must be in

writing, properly signed, dated, and with member's address and phone number. Hand-written resolutions will be considered only if legible as determined by the Resolutions Committee. Resolutions to be considered must be received no later than 12:00 p.m. (noon) on Friday, February 14, 2025 and should be addressed as follows:

David Olson represents District 1 on Barron Electric's Board of Directors, which includes the following townships: Brooklyn, Gull Lake, Stinnett, Hayward, Scott, Casey, Trego, Springbrook, Bass Lake, and Rusk.

- Receptionist Faith Christensen and Energy Use/Metering Technician Jordan Ellison were introduced to the Board.
- A report of vouchers for the month was presented as part of the board packet as follows: #103582 through #103699 from CCF Bank in the amount of \$466,122 with capital credit estate checks totaling \$24,868. Total receipts in the office \$4,027,476; total receipts by wire and ACH \$2,903,375; disbursements by ACH, EFT, wire \$5,747,155; transfer of funds was made for payroll \$233,333 and the power bill was paid on 10/30/2024 in the amount of \$2,057,832.
- A membership list of 65 was presented and approved without objection.
- Form 219 summarizing construction activity for the month of September in the amount of \$396,031.03 was presented for approval and included new services \$41,831.78; change jobs \$12,042.30; Other Work Order Projects \$342,156.95 and 3 retirements. The Form 219 stood approved as presented.
- Outages year-to-date stand at 85,500.41 consumer hours off, which is 51.09% above 2023 hours of 56,590.46. Overtime year-to-date is 3,224.25 hours, which is 16.73% above 2023 hours of 2,762.25.
