EPA's New Power Plant Rules Ignore Reliability Challenges

The Environmental Protection Agency (EPA) released four major new regulations for the electric industry. The power plant rule constrains existing coal and new natural gas plants by requiring them to deploy carbon capture and sequestration, a technology that is not yet proven or commercially available. Jim Matheson, CEO of the National Rural Electric Cooperative Association, remarked, "The new EPA rules ignores our nation's ongoing electric reliability challenges and is the wrong approach at a critical time for our nation's energy future." He noted that the power plant rule would force the early retirement of always-available generation sources and limit construction of new natural gas plants. Under the new rule, existing coal-fired units that

plan to operate past the start of 2039 must reduce emissions of carbon dioxide by 90% by 2032. The rule also requires new natural gas plants operating as baseload to capture or avoid 90% of their carbon emissions by 2032.

Ben Porath, Dairyland Power Cooperative's Executive Vice President and Chief Operating Officer, said, "Dairyland is committed to providing our members, including Barron Electric, with the safe, reliable and cost-competitive electricity that is essential to power homes and businesses. We are on a decarbonization journey that takes a measured approach to reducing our carbon intensity without compromising reliability and affordability. The proposed EPA Power Plant rule - as written - would retire dispatchable generation before the end of its useful life. Proposed solutions within the rule, such as converting coal-fired power plants to run on natural gas or to utilize carbon capture and storage (CCS) are costprohibitive and reliant on emerging, but unproven, technologies."

He added, "Dairyland is researching the viability of small modular nuclear reactors and battery storage, but there is currently no battery technology that can dependably or affordably replace the always-available resources our members rely on. We continue to work with NRECA and elected officials to advocate for common-sense policies and regulations."

\$15,820. Total receipts in the office \$2,409,148; total receipts by wire and ACH \$1,544,503; disbursements by ACH, EFT, wire \$2,976,700; transfer of funds was made for payroll \$202,974 and the power bill was paid on 03/27/2024 in the amount of \$2,092,685.

- Director Mandel reported from the Annual Meeting Committee meeting held prior to the board meeting. Discussion regarding 2025 Annual Meeting day and time of the week. Suggested a Tuesday night meeting at the BACC. The board approved Tuesday night as the day of the week for the 2025 Annual Meeting.
