## **Proposed Solar** Legislation

In August, Wisconsin Senator Duey Stroebel (Saukville) introduced SB 490 to the State Senate. Co-authored by State **Representative Tim Ramthun** (Campbellsport), the bill would allow third-party community solar programs in Wisconsin. Third-party community solar is when a non-utility entity builds a solar array and sells subscriptions for the power generated by the array to utility customers. As proposed, SB 490 would apply to investor-owned utilities, while electric cooperatives are currently exempt. However, policymakers could amend the bill and include cooperatives in the future.

Barron Electric supports renewable energy and commonsense solutions to reduce our carbon intensity. However, we want to make sure it is done in a way that is equitable for all members, supports a safe and reliable power grid, and doesn't push additional costs onto nonsubscribers. As a cooperative, we are concerned that, as written, the bill does not accomplish these objectives.

**Dairyland Power Cooperative** is our wholesale power provider and has set a goal to reduce their carbon intensity by 50 percent, over 2005 levels, by 2030. Currently, renewable energy makes up about 24 percent of Dairyland's generation mix. In January, they began purchasing the electricity generated from 52 megawatts (MW) of the Tatanka Ridge Wind Farm. By 2023, they will add the 149 MW Badger State Solar array into their energy mix. This is building on the 18 local, distributed solar facilities totaling 25 MW already located in Dairyland's four-state service area.

# **Electrical Safety During Fall Harvest**

Fall harvest is a busy time for farmers, but safety, especially around electrical hazards, should be a priority. "Overhead power lines often fade into the landscape, since we are so used to seeing them," says Erin Hollinshead, executive director of Safe Electricity. During harvest and anytime, precautions are needed around



power sources that include overhead and underground power lines. Safe Electricity advises the following safety guidelines:

- Inspect the height of the farm equipment to determine clearance.
- Use a spotter when operating large machinery near power lines.
- Access a grain bin from the side without a power line or pole.
- Keep equipment at least 10 feet away from power lines.
- Lower extensions to the lowest setting when moving loads.
- If equipment hits a power line, remain inside the cab unless there is smoke or fire. A downed powerline can electrify equipment, the cab, and the ground, or anything else in the area. Call 911, warn others to stay away, and wait for the utility crew to cut the power.
- To exit the cab safely, stand or crouch on a cab step and jump to the ground keeping both feet together. Do not make contact with the cab. Hop at least 50 feet away, keeping both feet together and touching the ground at the same time. Hopping decreases the chances of stepping from one voltage to another, which can create an electrical path through the body causing severe burns, shock and electrocution.

- Outages year-to-date stand at 9,130 consumer hours off, which is 58.05% below 2020 hours of 21,762. Overtime year-to-date is 977.25 hours, which is 21.51% above 2020 hours of 804.25.
